The day of court hundreds of Michael Jackson fans came to protest for Michael. The same fans came to the jail the day Murray was released.






This is where Michael Jackson was found dead. It is his house in Los Angeles.

In court murray's 4 ex-girlfriends and his current girlfriend all made statements about their contact with murray the night of Michael's death. He had talked to all of them either that day or that week.



In court Murray was tried with 17 violations concluding to michael's death. Most of the violations had to do with the lack of equipment and calling the police.

Murray inserted many drugs into a IV. It also was reported that because of so many Iv hook-up you couldn't find the veins in Michael's arms or hands.
